

## **PRIVACY and COOKIES STATEMENT**

This Statement relates to our privacy practices in connection with this Website. We are not responsible for the content or privacy practices of other websites. Any external links to other websites are clearly identifiable as such. Londinium fully respects your right to privacy in relation to your interactions with this Website.

### **Collection and Use of Information**

We fully respect your right to privacy, and will not collect any personal information about you on this Website without your consent.

Any personal information that you volunteer to us will be treated with the highest standards of security and confidentiality, strictly in accordance with the existing laws on Data Protection.

We do not collect any personal data about you on this Website, apart from information which you volunteer. Any information that you provide in this way is not made available to any third parties, and is used by us for the purpose for which you provided it.

You may at any time request a copy of any personal information we hold relating to you.

### **Use of Technical Information**

**Cookies:** Cookies are small pieces of information, stored in simple text files, placed on your computer by a website. Cookies can be read by the website on your subsequent visits. The information stored in a cookie may relate to your browsing habits on the website, or a unique identification number, so that the website can identify you on your return visit. Generally, cookies do not contain personal information from which you can be identified, unless you have furnished such information to the website.

Londinium uses **session cookies** i.e. cookies which only last for the duration of your visit to the Website and are deleted when you close your browser. These temporary session cookies used by Londinium are required to facilitate your use of our Website.

Londinium also uses **Google Analytics**, a web analytics service provided by Google, Inc. (“Google”), to gather statistics on our Website. We will use the information gathered to improve the services to our Website users. Google Analytics employs cookies to identify user sessions, which allows for the collection of important data about how users are using the site. Google Analytics uses only first-party cookies for data analysis. This means that the cookies are linked to our Website domain(s), and we will only use that cookie data for statistical analysis related to your browsing behaviour on our Website to help us to increase the usability and accessibility of our Website.

You can opt-out from being tracked by Google Analytics by downloading and installing Google Analytics Opt-out Browser Add-on for your current web browser: Google Analytics Opt-out Browser Add-on.

Londinium will make no attempt to identify individual visitors, or to associate the technical details listed above with any individual.

It is the policy of Londinium never to disclose such technical information in respect of individual Website visitors to any third party (apart from our Internet service provider, which records such data on our behalf and which is bound by confidentiality provisions in this regard), unless obliged to disclose such information by law.

The technical information will be used only by Londinium, and only for statistical purposes to help us to increase the usability and accessibility of our Website.

You should note that technical details, which we cannot associate with any identifiable individual, do not constitute “personal data” for the purposes of the existing Data Protection Acts.
